Each year in South Australia an average of 60 children are newly diagnosed with cancer. In addition to this, an average of 12 children relapse and 10 children pass away from cancer.

At present, the Childhood Cancer Association is supporting more than 300 families going through the childhood cancer journey.

How to make a bequest to Childhood Cancer Association

Because a bequest is a gift made through your Will, we strongly recommend that any change you wish to make is done in consultation with your lawyer or advisor.

Example of bequest wording

An example of bequest wording is set out below, but should be only used as a guide for you and your solicitor. The exact wording will depend on the type of bequest you wish to make.

I give [the sum of \$.....] or [.....% of the balance of my estate] or [specified assets] to the Childhood Cancer Association Incorporated of Level 1, 55 King William Road, North Adelaide SA 5006 (for its general purposes). The receipt of the Childhood Cancer Association Incorporated will be sufficient discharge to my Executor/Trustee and declare that my Executor/Trustee shall not be responsible for seeing to the application of that gift.

With no government funding, the continuation of our support relies 100% on the generosity & philanthropy of our supporters.

By leaving a bequest to the Childhood Cancer Association in your Will, you will ensure vital services and support for children with cancer and their families can continue well into the future.
